The service responsibilities stipulated below shall not be construed as an exhaustive list and the Contractor shall be required to provide additional services or to comply with ancillary responsibilities to the extent that this may be required for the effective compliance with the stipulated responsibilities:

- Carry out an initial inspection and subsequent routine inspections and submit reports at each inspection
- Excavate and remove existing galvanized flanged steel pipes and fittings
- Strip off and remove old 'Denso' tape
- Remove any surface rust/corrosion by abrasion (wire brush and/or chipping where required)
- Clean all surfaces with a high pressure water washer using a mixture of water and degreaser
- Carry out repairs to valves and remove valves and sandblast all coated exposed surfaces to bare steel
- Repair existing pipework where possible
- Apply primer suitable as a substrate for a urethane overcoat
- Prepare, clean and degrease high pressure pipe and • fittings

- Provide new galvanized steel medium grade pipes (SANS 062)
- Coat pipes and fittings with 'Wrapid Bond' and relay •
- Complete backfill and earthworks applicable for the completion of the repair works comprising of carting away of excavated materials and debris, importing of filling materials and scarifying to suit.
- Complete external and drainage works applicable for the completion of the repair works comprising of repairs to concrete kerbs, water channels and drains, paving, roads and road marking, etc.
- Preparation of monthly reports
- Occupational health & safety method statements & compliance
- Construction environmental management method statements & compliance

BRIEFING MEETING:

BID CONDITIONS:

- Tenderers are required to submit an original or certified B-BBEE Certificate from an accredited verification agency. Companies with annual turnover less than R10 million to submit an accountant letter confirming turnover.
- Tenderers must submit technical and financial proposals in two separate envelopes clearly marked "Envelop A -Technical Proposal" and "Envelope B - Financial Proposal". The financial proposal will only be opened should the technical proposal be deemed compliant and responsive.
- Non-signed "Form of Offer" in the financial proposal in "Envelope B" submission will result in the disqualification of the tender.
- Inclusion of Price Offer and/ or any price details in "Envelope A Technical Proposal" will result in the disqualification of the tender.
- Registration with CIDB is compulsory with contractor grading designation of 5SF Tenderers are advised that preference will be given to those companies which have local (East London) operational
- office in place at the time of the contract award
- Tenderers to provide certified copy of company registration certificate
- Tenderers to provide letter of good standing with Compensation Commissioner Tenderers to provide proof of ASIB certification of Installer status

EVALUATION:

The evaluation will be guided by the East London Industrial Development Zone procurement policy. Points will be awarded on the basis of Price and BBBEE.

• 10 Points for BBBEE

All tenders with functionality less than 75% of the total functional requirements will not be considered for the next stage of tender evaluation.
