- less than R10 million to submit an accountant letter confirming turnover. Tenderers must submit technical and financial proposals in two separate envelopes clearly marked "Envelope A -Technical Proposal" and "Envelope B – Financial Proposal". Then the financial proposal will only be opened
- should the technical proposal be found to be acceptable. Non-written and non-signed ELIDZ Price Schedule of the financial proposal in "Envelope B" submission will result in
  - the disqualification of the tender. Inclusion of Price Offer and/ or any price details in "Envelope A -Technical Proposal" will result in the disqualification
- of the tender. Tenderers are required to submit company registration documents and ELIDZ procurement handbook with their tender.
- **EVALUATION:**

The evaluation will be guided by the East London Industrial Development Zone procurement policy. Points will be awarded on the basis of Price and BBBEE.
