- Tenderers must submit technical and financial proposals in two separate envelopes clearly marked "Envelope A -Technical Proposal" and "Envelope B-Financial Proposal". Then the financial proposal will only be opened should the technical proposal be found to be acceptable.
- Non-written and non-signed ELIDZ Price Schedule of the financial proposal in "Envelope B" submission will result in the disqualification of the tender.
- Inclusion of Price Offer and/ or any price details in "Envelope A -Technical Proposal" will result in the disqualification of the tender.

**EVALUATION:** The evaluation will be guided by the East London Industrial Development Zone procurement policy. Points will be awarded on the basis of Price and BBBEE.

- 90 Points for Price 10 Points for BBBEE
- All tenders with functionality less than 70% of the total functional requirements will not be considered for the next stage of tender evaluation.
