BID CONDITIONS:

- Tenderers are required to submit a Verified original or certified B-BBEE Certificate. Companies with annual turnover less than R10 million to submit an accountant letter or affidavit confirming turnover and black ownership split.
- Tenderers must submit technical and financial proposals in two separate envelopes clearly marked "Envelope A
 -Technical Proposal" and "Envelope B Financial Proposal". Then the financial proposal will only be opened should
 the technical proposal be found to be acceptable.
- Non-written and non-signed ELIDZ Price Schedule of the financial proposal in "Envelope B" submission will result in the disqualification of the tender.
- Inclusion of Price Offer and/or any price details in "Envelope A -Technical Proposal" will result in the disqualification
 of the tender.
