- Bidders are required to submit a Verified original or certified B-BBEE Certificate. Companies with annual turnover less than R10 million to submit an accountant letter confirming turnover.
- Bidders are required to submit company registration documents and ELIDZ procurement handbook with their tender.
- Bidders should be registered on CSD database from Treasury and in possession of a MAAA number

### EVALUATION:

The evaluation will be guided by the East London Industrial Development Zone procurement policy. Points will be awarded based on Technical Functionality Matrix/Criteria.

### Score breakdown:

- 100 Points for Technical Functionality

No innovations with functionality less than 70% of the total functional requirements will be considered for the next stage of evaluation.
