### **Section 2: EOI SCOPE OF REQUIREMENTS**

#### **1 INTRODUCTION**

The East London Development Zone SOC Ltd is a “greenfield” development project that is part of a sub-regional economic growth and employment creation initiative driven by the government’s micro-economic reform strategy, as implemented by the South African Department of Trade and Industry.

The development and operation of the Zone are managed by the East London Industrial Development Zone SOC Ltd, under authorization by the State. The company was established to plan and implement the East London IDZ in a phased manner for manufacturing and other industrialists and features world class infrastructure and dedicated utility and other services.

#### **2 KEY OBJECTIVES OF THIS EOI PROCESS**

1. The successful bidder will be offered an opportunity to purchase, capture and relocate approximately 90 (ninety) impala at the offered price per Impala, not lower than the reserved price per Impala.
2. The respondents price offer must be considerate of all costs for the respondents own account related to the purchase capture and relocating of each Impala from the ELIDZ.  
These costs include but might not be limited to:
  - Costs of applicable permits required to purchase, capture and relocate Impala from the ELIDZ
  - Costs of verifying the number of Impala available for purchase, capture and relocating
  - Cost of herding & capturing the Impala in preparation for relocating from the ELIDZ
  - Cost of applicable transportation required to capture and relocate Impala from the ELIDZ

#### **3 GENERAL RESPONDENT OBLIGATIONS**

The Respondent (s) must comply with the requirements stated in this EOI as follows:

- Must submit proof of being a registered game Lodge or similar entity permitted to house such wildlife for various purposes.
- Must have the necessary permits to purchase and relocate the impala.
- Submit an adequate capturing and relocation plan for the approval by the ELIDZ.

The respondent must verify the ELIDZ provisional count pf 90 Impala located at the ELIDZ available for purchase capture and relocating.

- To this end the respondent is required to pay for the total number of Impala verified by the respondent and the ELIDZ as available for purchase, capture and relocating.

#### **4 CONFIDENTIALITY AND COMPLIANCE**

This EOI and information contained herein or provided for purposes thereof, remain the property of ELIDZ and may not be reproduced, sold or otherwise disposed of. All recipients of this document (whether a EOI is submitted or not) shall treat the details of this document as strictly private and confidential.

Information disclosed in this EOI is given in good faith and only for the purposes of providing sufficient information to the Respondent to enable submission of a well-informed and realistic EOI.

#### **5 UNDERTAKINGS BY RESPONDENT**

It will be accepted that the Respondent, on submitting the EOI response, has read, understood and accepted all the terms and conditions of the document. The submission of an EOI by any Respondent shall presume complete

acceptance of the terms and conditions of the document. All qualifications and or exceptions should be noted in the EOI Response document.

## **6 COSTS TO RESPOND TO THE EOI**

All Respondents wishing to submit an EOI response must be in possession of this document, the EOI. The ELIDZ will not be responsible for or pay any expense or losses which may be incurred by any Respondent in the preparation and submission of the EOI and the costs of the EOI at all stages of the EOI process. Costs, if any, will be for each Respondent's own account.

The ELIDZ reserves the right to invite certain Respondents to present or otherwise demonstrate their proposed solution as per their EOI, at the Respondent's own cost.

## **7 AUTHORITY OF SIGNATORY**

- 7.1 If the EOI Respondent is a company, a certified copy of the resolution of the Board of Directors (i.e. personally signed by the Chairman or Secretary of the Board) authorising the person who signs this EOI to do so and any other documents and correspondence in connection with this EOI and/or agreement on behalf of the company, must be submitted with their EOI.
- 7.2 If the EOI Respondent is a partnership, a certified copy of the resolution of the partners (personally signed by all the partners) authorising the person who signs this EOI to do so and any other documents and correspondence in connection with this EOI and/or agreement on behalf of the partnership, must be submitted with this EOI.
