## SUPPLY AND DELIVERY OF A SEVEN-SEATER CREW-BUS VEHICLE

### SCOPE OF WORK:

The ELIDZ invites suitably qualified and competent service providers to respond to the Request for Proposals (RFP) **supply and delivery of a seven-seater crew-bus to the East London Industrial Development Zone.**

### BRIEFING MEETING:

**Note:** There will be no briefing session. Tenderers are required to physically inspect the vehicle being offered for trade-in purposes. Viewings will be open between **10:00 and 14:00 on the 15th of March 2021**. Tenderers are encouraged to submit written questions by emailed to [lulama@elidz.co.za](mailto:lulama@elidz.co.za) not later than the **23 March 2021 at 16h30**.

### BID CONDITIONS:

- Tenderers are required to submit a Valid SARS Tax Clearance Certificate with their tender.
- Tenderers are required to submit a Verified original or certified B-BBEE Certificate.
- Tenderers must submit technical and financial proposals in two separate envelopes clearly marked "**Envelope A - Technical Proposal**" and "**Envelope B – Financial Proposal**". Then the financial proposal will only be opened should the technical proposal be found to be acceptable.
- A non-written and non-signed ELIDZ Price Schedule in the financial proposal in the "Envelope B" submission will result in the disqualification of the tender.
- Inclusion of Price Offer and/or any price details in "Envelope A - Technical Proposal" will result in the disqualification of the tender.
- Tenderers are required to submit company registration documents and ELIDZ procurement handbook with their tender.
- Tenderers should be registered on CSD database from Treasury and in possession of a MAAA number.

### EVALUATION:

The evaluation will be guided by the East London Industrial Development Zone procurement policy. Points will be awarded on the basis of Price and BBBEE.

### Score breakdown:

- 80 Points for Price
- 20 Points for BBBEE

All tenders with functionality less than 70% of the total functional requirements will not be considered for the next stage of tender evaluation.

### PROPOSAL DOCUMENT & SUBMISSION:

The RFP document will be available for download on **8th March 2021, 12h00 (Noon)**, at [www.elidz.co.za](http://www.elidz.co.za) under **Opportunities >> Tenders**.
