The zone is already operational and currently houses a number of manufacturers that supply products for the local and international markets.

SCOPE OF WORK:

The ELIDZ invites suitably qualified and competent service providers to respond to the Request for Proposals (RFP) for the provision of **Grass Cutting Services at the East London Industrial Development Zone.**

BRIEFING MEETING:

Note: A non-compulsory Briefing or Site Clarification Meeting with representatives of the Employer will take place on the **28th May 2021, 10h00 at the East London IDZ Conference centre in Zone 1A.** Participants arriving more than 15 minutes late from start time will not be allowed to attend the meeting. All Covid-19 regulations to be adhered to.

BID CONDITIONS:

- Tenderers are required to submit a Valid SARS Tax Clearance Certificate with their tender.
- Tenderers are required to submit a Verified original or certified B-BBEE Certificate. Companies with annual turnover less than R10 million to submit a BBEE affidavit confirming their Black Ownership Status.
- Tenderers must submit technical and financial proposals in two separate envelopes clearly marked "**Envelope A - Technical Proposal**" and "**Envelope B – Financial Proposal**". Then the financial proposal will only be opened should the technical proposal be found to be acceptable.
- A non-written and non-signed ELIDZ Price Schedule in the financial proposal in the "Envelope B" submission will result in the disqualification of the tender.
- Inclusion of Price Offer and/or any price details in "Envelope A - Technical Proposal" will result in the disqualification of the tender.
- Tenderers are required to submit company registration documents and ELIDZ procurement handbook with their tender.
- Tenderers should be registered on CSD database from Treasury and in possession of a MAAA number.
- Tenderers that submit as a joint venture should submit a consolidated BBBEE certificate in order to achieve points in terms of the preference points system.

EVALUATION:

The evaluation will be guided by the East London Industrial Development Zone procurement policy. Points will be awarded on the basis of Price and BBBEE.

Score breakdown:

- 80 Points for Price
- 20 Points for BBBEE

All tenders with functionality less than 70% of the total functional requirements will not be considered for the next stage of tender evaluation.

PROPOSAL DOCUMENT & SUBMISSION:

The RFP document will be available for free download on **21 May 2021 from 12h00 (Noon)**, at www.elidz.co.za under **Opportunities >> Tenders.**

The tender must be placed in a sealed envelope marked "Confidential" with the name/address of the submitting company and the tender reference number. They must be deposited in the applicable tender box in **ELIDZ's Head offices, East London Industrial Development Zone Head Office Building, Lower Chester Road, Sunnyridge, East London.**

ELIDZ will not be responsible for tenders placed in an incorrect tender box. No late tenders will be accepted. Only original tenders will be accepted. Telegraphic, telephonic, telex, facsimile and e-mail will not be accepted.
