

# REQUEST FOR PROPOSALS (RFP)

## PROVISION FOR MAINTENANCE SERVICE OF THE ELECTRIC FENCING

The **East London Industrial Development Zone SOC Ltd** is the operator of the East London Industrial Development Zone (ELIDZ), an entity which exists to help manufacturers to become globally competitive through the development and efficient management of a modern, purpose-built industrial location, which offers investing industries a streamlined business environment enhanced by a range of supporting services. The zone is already operational and currently houses a number of manufacturers that supply products for the local and international markets.

### SCOPE OF WORK:

Tenders are being invited with suitably qualified and experienced service providers for provision for maintenance service of the electric fencing in the East London Industrial Development Zone, located at our facilities within the West Bank area of the Buffalo City Metropolitan Municipality.

The successful tenderer will be required to enter into a three (3) years contract to carry out maintenance services of electric fencing within the East London Industrial Development Zone SOC Ltd.

The Services include the following summarized scope of work:

- Complete daily inspection/test of electric fence network.
- Preparation and approval of weekly routine repair and replacement program.
- Kiosk inspection including checking the operation of all energizers, cleaning battery terminals, battery charging rates, battery load tests, battery chargers, vacuum kiosk, clean and replace filters where required.
- Inspect electric fence including wiring joints terminations, tensions and earths.
- Check electric fence furniture/equipment including strain and damage insulators, tensioners and bridges.
- Attend electric fence failures including cleaning fence equipment and remove corona tracing due to salt built up.
- Vegetation control comprising of patrolling the entire ELIDZ fence line and administer MAMBA or approved vegetation control mixture.
- Check and test fibre intrusion detection equipment and palisade fence.
- General routine repairs & replacement of defective equipment.
- Callouts to attend to defective equipment.
- Compile a monthly preliminary payment valuation and report.
- Occupational health & safety method statements & compliance.
- Construction environmental management method statements & compliance.

### BRIEFING MEETING :

**Note: A Non-Compulsory Briefing with representatives of the Employer will take place Virtually via Microsoft Teams on 22 June 2022 starting at 10h00. A link to the meeting will be sent an hour prior to the meeting. This registering to attend is to be done by no later than 09:00 on the 21 June 2022.**

### BID CONDITIONS:

- Tenderers are required to submit a Valid SARS Tax Clearance Certificate with their tender, or the relevant SARS pin code which will allow the ELIDZ to confirm the tenderers tax status on-line.
- Tenderer must be registered on Central Supplier Database (CSD) from National Treasury and MAAA number must be provided.
- Tenderers should submit a valid original or certified B-BBEE certification. Companies with annual turnover less than R10 million to submit an accountant or SARS letter confirming turnover.
- Tenderers to provide certified copy of Company Registration Certificate.
- Tenderers to provide Letter of Good Standing from Compensation Commissioner.
- Tenderers must submit technical and financial proposals in two separate envelopes clearly marked "**Envelope A -Technical Proposal**" and "**Envelope B-Financial Proposal**". The financial proposal will only be opened should the technical proposal be found to be acceptable.
- A non-signed "Form of Offer" in the financial proposal in the "Envelope B" submission will result in the disqualification of the tender.
- Inclusion of Price Offer and/ or any other price related details in "Envelope A-Technical Proposal" will result in the disqualification of the tender.
- The successful Tenderer will be required to have sufficient and competent staff available to commence full time operations in accordance with the contract with effect from the Commencement Date, failing which the contract will be awarded to the next most preferred Tender.
- The tender will be required registration with the CIDB in the category **2EB** is compulsory for companies wishing to submit tenders.
- A service provider will be required to submit a proof of registration of the staff registered with department of labour as an Installation Electrician as per Electrical Machinery Regulation 13(1) to issue the installation certificate of compliance. Failure to submit this document will result in an automatic disqualification.
- Tenderers are required to provide proof of Registration with PSIRA (Private Security Industry's Regulatory Authority). Failure to submit this document will result in an automatic disqualification.

### EVALUATION:

The evaluation will be guided by the ELIDZ procurement policy. Points will be awarded on the basis of Price and BBEE.

### Score breakdown:

- 80 Points for Price
- 20 Points for BBEE

All tenders not providing compulsory responsive documentation and with functionality scoring less than 70%, will not be considered for the next stage of tender evaluation.
