

# REQUEST FOR PROPOSALS (RFP)

## REPAIRS, REPLACEMENT AND SERVICING OF ELIDZ FIRE BOOSTERS AND HYDRANTS FOR A PERIOD OF SIX MONTHS

The zone is already operational and currently houses a number of manufacturers that supply products for the local and international markets.

### SCOPE OF WORK:

The ELIDZ invites suitably qualified and competent service providers to respond to a Request for Tender (RFT's) for repairs, replacement, and servicing of Fire Boosters and Hydrants in the East London Industrial Development Zone, located at our facilities within the West Bank area of the Buffalo City Metropolitan Municipality

The qualified service provider will be required to:

1. Familiarise himself/herself with the ELIDZ fire boosters/hydrants.
2. Inspect/Check the condition of the Fire boosters and fire hydrants.
3. Routine repairs and replacement of defective equipment.
4. Refurbish/Clean up dirty or faulty fire boosters and hydrants.
5. Refurbish and service fire boosters and fire hydrants connections.
6. Callouts to attend to defective equipment.
7. Preparation of monthly reports.
8. Ensure compliance to ELIDZ Safety Health, Environment and Quality (SHEQ).
9. Allow provisional sums for servicing the building instructed by the ELIDZ Project Manager.

### BID CONDITIONS:

- Tenderers are required to submit a Valid SARS Tax Clearance Certificate with their tender, or the relevant SARS pin code which will allow the ELIDZ to confirm the tenderers tax status online.
- Tenderers must be registered on Central Suppliers Database (CSD) ) from National Treasury and MAAA number must be provided.
- Tenderers should submit a Valid original or certified B-BBEE certification or Sworn Affidavit
- Tenderers to provide certified copy of Company Registration Certificate
- Tenderers to provide Letter of Good Standing from Compensation Commissioner
- Tenderers must submit technical and financial proposals in two separate envelopes clearly marked **“Envelope A-Technical Proposal”** and **“Envelope B – Financial Proposal”**. Then the financial proposal will only be opened should the technical proposal be found to be acceptable.
- A non-signed “Form of Offer” in the financial proposal in the “Envelope B” submission will result in the disqualification of the tender.
- Inclusion of Price Offer and/ or any other price related details in “Envelope A -Technical Proposal “will result in the disqualification of the tender.
- The successful Tenderer will be required to have sufficient and competent staff available to commence full time operations in accordance with the contract with effect from the Commencement Date, failing which the contract will be awarded to the next most preferred Tender.

### EVALUATION:

The evaluation will be guided by the East London Industrial Development Zone procurement policy. Points will be awarded on the basis of Price and Specific goals.

#### Score breakdown:

- 80 Points for Price
- 20 Points for Specific goals

All tenders with functionality less than 70% of the total functional requirements will not be considered for the next stage of tender evaluation.
