



The East London Industrial Development Zone (ELIDZ) Consulting and Analytical Services (CAS) Laboratory, an accredited laboratory by the South African National Accreditation System (SANAS), is situated at the ELIDZ Science and Technology Park (STP). The ELIDZ CAS Laboratory, boasting state-of-the-art equipment, enhances the analytical testing capabilities for the water, food, and soil industries in the Eastern Cape Province.

The laboratory adheres to government and industry regulations, which establish guidelines for acceptable pathogenic and non-pathogenic micro-organisms in specific samples and food groups. It also ensures compliance by following green drop specifications and adhering to SANAS 241, which serves as a benchmark for environmental testing.

The ELIDZ CAS Laboratory is staffed with skilled chemists, biochemists, and microbiologists, offering a wide spectrum of chemical and microbiological analysis services.

In our laboratory, we analyse various types of samples, including:

- Surface Water Analysis: Testing water from rivers, lakes, dams, and pools to assess its quality and potential contaminants.
- Groundwater / Borehole Water Analysis: We examine water from boreholes, wells, and spring sources.
- Drinking Water Analysis: Testing of tap water, bottled water, and treated surface or groundwater to verify its fitness for consumption.
- Wastewater Analysis: We assess wastewater and its compliance with environmental standards.
- Inorganic Analysis Major Cations/Anions: We analyse the major cations and anions present in water to understand its chemical composition.
- Physicochemical Analysis: Examination of physical and chemical properties of substances.
- Microbiological Analysis: We perform microbial testing to detect the presence of microorganisms.
- **Metal Scan:** We conduct tests to identify the presence of metals in various samples.
- Microbiological Food Analysis: We analyse food products for microbial contamination and safety.
