

ELIDZ-STP HOSTS AN INNOVATIVE TRAINING WORKSHOP ON ELECTRIC VEHICLE FUNDAMENTALS

The East London Industrial Development Zone, Science and Technology Park (ELIDZ-STP) recently hosted a five-day Professional Certificate of Competency in Fundamentals of Electric Vehicles (EV) training workshop. The programme is designed to upskill professionals, entrepreneurs, and the unemployed in the automotive sector by providing in-depth knowledge and practical experience in EV technology.



The workshop took place from 10 - 14 March 2025 at the ELIDZ-STP, drawing significant interest from across the Eastern Cape. Out of over 800 applications, 30 carefully selected participants were chosen to attend, ensuring a focused and impactful training experience.

These participants included engineers, mechanics, auto-electricians, and other professionals and entrepreneurs already working in or looking to transition into the EV sector. Their enthusiasm reflected a growing interest in electric mobility and the need for specialised skills in this rapidly evolving industry.

The workshop ensured that participants gain a well-rounded understanding of electric vehicles. Training was conducted by an industry expert from the Engineering Institute of Technology (EIT), an Australian-based organisation recognised by the South African Qualifications Authority (SAQA).

The training covered a broad spectrum of EV technology fundamentals, including:

- Introduction to EVs: Understanding electric, hybrid, and fuel cell
 which are the second and the second are the second
- Vehicle Components: EV layouts, power electronics, batteries, and charging infrastructure.
- Electric Propulsion Systems: Motors, energy consumption, and performance
- Hybrid Drive Trains: Electrical coupling, control strategies, and design principles.
- Safety & Hazard Management: High-voltage precautions, safe work procedures, and hazard mitigation.

Participants engaged in interactive learning exercises, applying their newly acquired knowledge to real-world scenarios.

Participants in due course will be issued with industry-recognised professional certificates. This certification is a critical step in preparing South Africa's workforce to meet the increasing demand for electric vehicles and the infrastructure needed to support them.

The initiative aligns with the South African Automotive Masterplan (SAAM) 2035, which highlights skills development as a key strategic pillar in achieving the country's long-term objectives for the automotive industry. Developing expertise in EV technology is essential as South Africa moves toward a sustainable, low-carbon economy.

With more than 120 automotive manufacturers operating in the Eastern Cape, the sector plays a pivotal role in the region's economy. The province is home to four major automotive manufacturers, with three based in Nelson Mandela Metropolitan Municipality and one in Buffalo City Metropolitan Municipality. As the industry shifts toward electric mobility, the ELIDZ-STP aims to ensure that local professionals and entrepreneurs remain competitive and well-equipped for emerging opportunities.

One of the challenges facing South Africa's transition to electric mobility is the lack of formal qualifications focused specifically on EV technology.

To bridge this gap, the ELIDZ-STP is leveraging on its global networks such as International Association of Science Parks (IASP) and other global partners to provide specialised, high-quality training programs.

The goal is to equip professionals with cross-disciplinary expertise in key areas such as:

- Prototype development (hardware, software, and testing).
- Electrical and electronic systems for EV design.
- Embedded product development for in-vehicle and external data networking.
- Problem-solving, analytical, and creative skills for EV innovation.

By collaborating with internationally recognised institutions, the ELIDZ-STP is ensuring that South African professionals receive world-class training that meets both local and global industry standards.

As the global shift to electric mobility accelerates, initiatives like this training workshop are vital for creating a competitive and sustainable workforce. EMPOWERING COMMUNITIES: ELIDZ'S 2024/25 FY CORPORATE SOCIAL INVESTMENT INITIATIVES

Through its Corporate Social Investment (CSI) initiative, the East London Industrial Development Zone (ELIDZ) is consistent in its dedication to improving communities. ELIDZ implemented a number of significant initiatives during the 2024/2025 financial year with the goal of promoting education, youth development, community welfare, and economic empowerment. These programs significantly improved a number of communities in the Eastern Cape through partnerships and tireless efforts.

Educational Support

As an essential element of the CSI program, ELIDZ made education a top priority, guaranteeing that students from underprivileged backgrounds received muchneeded assistance. The contribution of 120 full school uniform kits helped a number of East London schools, such as Umtiza High School, Sinomonde Primary School, and Coveridge Primary School. These contributions made it possible for learners to go to school with confidence and dignity.

Additionally, Gcinubuzwe High School and Three Crowns Senior Primary School in Lady Frere received R50,000 worth of school shoes and sanitary towels from ELIDZ in collaboration with the Eastern Cape Provincial Government's Back-to-School Program. To ensure that a wider range of disadvantaged learners benefited from the program, ELIDZ and Teelo Foundation supplied school uniforms to several schools in Tsholomnqa, the event took place in Xhamini Hall as part of their ongoing commitment to creating a pleasant learning environment.

The opening of Umtiza High School's Community-Based Digital (4IR) Computer Laboratory was one of the most revolutionary educational efforts. This project, which had the total cost of R550,000 (R350,000 from Microsoft South Africa and R200,000 from ELIDZ), sought to improve digital literacy and close the digital gap. With 30 laptops, internet access, and backup power, the state-of-the-art lab, which is located in a transformed shipping container, provides learners and the local community with essential technology resources.

Sports and Youth Development

Understanding the importance of sports for young people's development, ELIDZ made year-round investments in a range of sports-related projects. ELIDZ CEO Thembela Zweni and Eastern Cape Premier Oscar Mabuyane

collaborated to donate R120,000 worth of sporting goods to Cosmos Sports Club, Evergreen Rugby Club, and Hotspot Boxing Academy. In the same spirit, the West Bank Sports Council and the BCM Suns Wheelchair Basketball Club were given essential equipment to further promote inclusivity and sports participation in Buffalo City.

Community Upliftment and Social Welfare

ELIDZ's social responsibility initiatives went beyond sports and education. ELIDZ renovated the Masizakhe Children's Home in honour of Nelson Mandela Month in collaboration with Boratech Energy Group and Junoscan Construction. Along with fixing structural issues like roof leaks, painting, plumbing, and electrical repairs, the team delivered necessities like a heavy-duty washing machine.

In yet another act of kindness, ELIDZ demonstrated its dedication to helping individuals in need of hospice care by providing necessary materials to St. Bernard's Hospice. Furthermore, a container facility was given to the Trauma and Rehabilitation Centre (TRC) in Nxamnkwana Village, Mdantsane, enhancing its ability to assist members of the community who are experiencing difficulties.

Acknowledging the role of sustainable agriculture in economic development, ELIDZ donated farming equipment to the Rabula Farming Cooperative in Keiskammahoek. This initiative aims to boost local agricultural productivity, foster job creation, and contribute to food security within the region.

Demonstrating its commitment to social cohesion, ELIDZ hosted its Annual Christmas Party for the elderly in Ward 46, East London. The event was an expression of gratitude


