BID CONDITIONS:

- Accredited Valid Original or Certified B-BBEE Certificate or Letter from an Accountant confirming Annual Turnover for EMES - Sworn Affidavit confirming annual turnover and B-BEE management split of company
- Company Profile indicated nature of business in ICT space
- JV Participation Documentation (If applicable)
- Valid Proof of Office Location
- Skills Summary including certificate/s and Curriculum Vitae/s including CISCO, HP, VEEAM expertise and qualifications.
- Three (3) Completed Reference Letters
- Completed and Signed ELIDZ Procurement Handbook with all relevant supporting documentation (Tax clearance or SARS PIN etc.)
- CSD Registration Certificate not older than 10 days from tender closing
- Tax Clearance Certificate or electronic access PIN obtained from SARS's new Tax Compliance Status (TCS) system
- Consortia / Joint Ventures must submit a separate Tax Clearance Certificate for each party.

EVALUATION:

The evaluation will be guided by the East London Industrial Development Zone procurement policy. Points will be awarded on the basis functionality and eligibility criteria.

Score breakdown:

- 70 - Points Functionality/Technical Evaluation

All respondents with functionality less than 70% of the total functional requirements will not be considered.
