- ☐ Tenderers are required to submit a copy of CIPC Registration;
- ☐ Tenderers are required to submit a Certified copy(s) of members Id's;
- ☐ Tenderers are required to submit a copy of share certificate;
- ☐ Tenderers are required to submit a Proof of Disability from Medical Practitioner ;
- ☐ Tenderers are required to submit a Proof of Office Location (lease agreement, statement of account from the municipality and/or confirmation of address/clearance from the municipal councilor);
- ☐ Tenderers are required to submit a Valid SARS Tax Clearance Certificate with their tender, or the relevant SARS pin code which will allow the ELIDZ to confirm the tenderers tax status on-line;
- ☐ Tenderers must be registered on Central Supplier Database (CSD) from National Treasury and MAAA number must be provided;
