

# REQUEST FOR PROPOSALS (RFP)

## RE-TENDER: PROVISION FOR MAINTENANCE SERVICE FOR ELECTRIC FENCING

The zone is already operational and currently houses a number of manufacturers that supply products for the local and international markets.

### SCOPE OF WORK

Tenders are hereby invited from suitably qualified and experienced service providers for the **TENDER: PROVISION FOR MAINTENANCE SERVICE FOR ELECTRIC FENCING** in the East London Industrial Development Zone, located at our facilities within the West Bank area of the Buffalo City Metropolitan Municipality.

The Services include the following summarized scope of work:

1. The provision of suitably qualified personnel during normal working hours
2. Scheduled and unscheduled maintenance activities required for Electric Fence Services
3. The provision of urgent and emergency response services related to Electric Fence, on a 24/7/365 basis

### BID CONDITIONS:

- Tenderers are required to submit a Valid SARS Tax Clearance Certificate with their tender, or the SARS pin code
- Tenderers should submit a valid original or certified B-BBEE Certificate from an accredited verification agency. Companies with annual turnover less than R10 million to submit an accountant letter confirming turnover.
- Tenderers are required to complete and sign the ELIDZ Procurement Handbook
- Tenderers to provide certified copy of Company Registration Certificate
- Tenderers to provide Letter of Good Standing from Compensation Commissioner
- Tenderers must submit technical and financial proposals in two separate envelopes clearly marked "Envelope A -Technical Proposal" and "Envelope B – Financial Proposal". The financial proposal will only be opened should the technical proposal be deemed acceptable.
- A non-signed "Form of Offer" in the financial proposal in the "Envelope B" submission will result in the disqualification of the tender.
- Inclusion of Price Offer and/ or any other price related details in "Envelope A-Technical Proposal" will result in the disqualification of the tender.
- The successful Tenderer will be required to have sufficient and competent staff available to commence full time operations in accordance with the contract with effect from the Commencement Date, failing which the contract will be awarded to the next most preferred Tender.
- In the event that the successful Bidder has been awarded the contract with value above R5 000 000.00 for the same goods/services on a consecutive basis, the successful Bidder will be required to submit a Supplier development plan for SMMEs to be agreed with the ELIDZ.
- Tenderers are required to provide proof of Registration with PSIRA (Private Security Industry's Regulatory Authority).
- A registered and operational office within the Buffalo City municipal boundaries will be given preference
- The tender will require registration with the CIDB in the category **6EB/EP or higher is compulsory**.
- A service provider will be required to submit proof of registration of the staff registered with department of labour as an Installation Electrician as per Electrical Machinery Regulation 13(1) to issue the installation certificate of compliance. Failure to submit this document will result in an automatic disqualification.

### EVALUATION:

The evaluation will be guided by the ELIDZ procurement policy. Points will be awarded on the basis of Price and Specific goals.

#### Score breakdown:

- 80 Points for financial offer
- 20 Points for Specific goals

All tenders not providing compulsory responsive documentation and with functionality scoring less than 70%, will not be considered for the next stage of tender evaluation.
